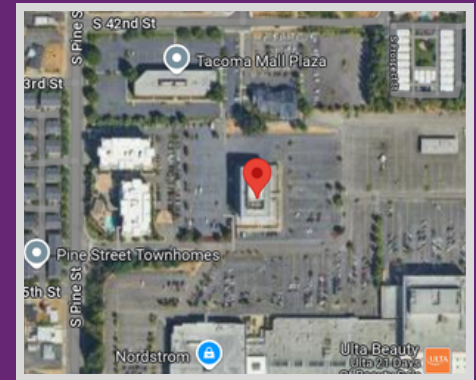

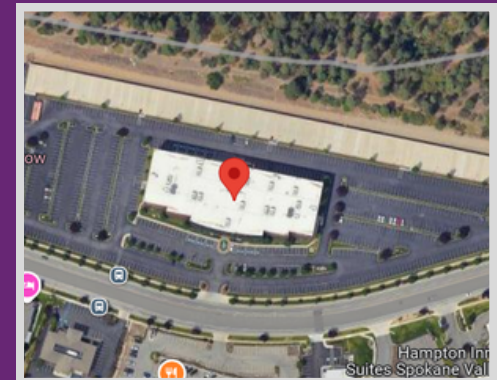

Cami Feek (she/her)

Appointed Commissioner for Employment Security Department (ESD) by Gov. Jay Inslee

Cami Feek was appointed commissioner for the ESD by Gov. Jay Inslee in June 2021. Prior to that, she served as ESD's acting commissioner, deputy commissioner, and chief operating officer. Her career in state government started back in 1996 in a non-permanent role in a mail room. She rose to executive leadership through hard work, dedication to public service, and living her values of teamwork and servant leadership.

In addition to laying the groundwork for the successful launch of Paid Family and Medical Leave, Cami has also led other major government transformation, such as creating rules for competitive contracting when civil service reform launched.

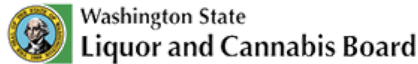
